### ON FARM



### **FARM Antibiotic Stewardship Program**

Producing a nutritious and safe product for our customers and families has been and always will be a top priority for our member-owners. This module provides continuous education for farmers to continue to keep cows healthy and our milk supply safe.

### FARM Environmental Stewardship Assessment

Since 2020, we have actively participated in the FARM Environmental Stewardship Assessment survey with our farmers. This program asks farmers questions related to their production totals, feed rations, electricity and gas usage, and manure management practices they use on their farms. It not only shows us where our farmers are at, but it also gives the chance for the farmer to see what areas they both excel in, and also could improve on.

### PROCESSING PLANT

In 2021, we completed a three-part expansion project where we build a new state of the art cheese plant, new milk receiving facility, and added on to our whey drying plant. Not only did this give us more production capacity, it also gave us opportunities to look at diversifying our product mix for the future. This expansion also gave us the ability to add over 40 more employees to our company.

Our plant is Safe Quality Foods (SQF) certified and operates in compliance with local, state and federal regulations. Having our own product testing and pathogen lab on-site allows us to test our products in a timely manner.

On average, over 80% of our water usage is cow water, which is evaporated off our milk





We at First District Association pride ourselves in producing high quality dairy foods. The backbone to producing these products are our dedicated employees. Maintaining an effective and stable workforce is a big contributor to our successes. We support and contribute to the success and future of our employees with employee development through trainings and programs to enhance skills needed to succeed in the workplace.

### **Recycling**

We recycle everything from cardboard, to metal, to cow water. We try to utilize and find a resourceful home for everything we use.

In 2021, we recycled over 200,000 pounds of waste

### **Safety**

Our employee's safety is our number one priority. To ensure their safety in their work environment, we plan and implement multiple safety trainings to reassure preparedness in any situation.

### **GIVING BACK**

We support the communities and organizations that are important to our employees and member-owners. Any way we can give back to the groups that help support and grow the future generation of agriculture enthusiasts, we do.

Every year, we award scholarships to our member-owners. The future of the agriculture industry is critical, that is why we support and encourage their efforts in continuing their future education and impact for the dairy industry. We also provide internship opportunities in various areas of our company to help expand students' knowledge of careers in agriculture.

#### **Dairy Donation Challenge**
